*Students who attend the Aviat Care program have a structured environment with homework time, snack, outdoor or indoor play time, and planned activities, especially on half days. The program is held in the Cafeteria and selected classrooms.*

*Our program is licensed by the State of Virginia, and our director and all staff are screened and approved by the Virginia Department of Social Services.*

### **Program Hours:**

*NO MORNING PROGRAM – School Opens 7:00 AM*

*Afternoon Program      3:10 – 6:00 PM*

*Half Days                      11:30 – 6:00 PM*

Aviat Care opens on the first day of school, Aug 22<sup>nd</sup>. It is not open when school is not in session.

The afternoon program closes at 6 PM on Dec. 19<sup>th</sup> for our Christmas holiday and 3 PM April 1<sup>st</sup> for our Easter holiday. The afternoon program is not open on Jan. 30<sup>th</sup> (Academic Fair) and the last two days of school in June 11<sup>th</sup> & 12<sup>th</sup> (pending snow days).

### **Program Fees:**

- Registration fee      \$45.00/family (due each school year)
  - Hourly rates              \$10.00/one child, if registered; \$12.00 if not registered.
- \*Registered families with 2 or more children signed in at the same time will receive a 25% discount.

**Unregistered families receive no discount.**

**Unregistered families will be charged a \$3.00 walk-in fee, and after 15 minutes are charged the unregistered hourly rate.**

*The afternoon program is based upon use. **The hourly rate is charged for any part of an hour used.** Students not picked up by 6PM will be charged a late pick up fee of \$15 for every quarter hour.*

### **Procedure for Registration:**

Please complete the registration form in its entirety. Although this may repeat information on your school forms, we are required by the state licensing office to maintain separate files. **We must have two emergency contacts, with their names, phone numbers, and addresses. We must have your pediatrician's full name, address, and telephone number.** Thank you for filling out the registration form carefully. **Parents or guardians may not be listed as emergency contacts.**

Once registered, your child may use the program at any time. Please inform your child's teacher if you will be using the program or if there is any change in your plans. Students who are not registered for the program but remain at the school after carpool is finished (around 3:30) will be signed in to Aviat Care.

**Unregistered families will be charged a \$3.00 walk-in fee, and after 15 minutes are charged the unregistered hourly rate.**

### **Sign-out Procedures:**

Until our staff is familiar with you or with your designated driver, we will require a valid driver's license or picture ID. We cannot release your child to anyone not listed on your registration form unless we receive this change in writing and that person produces a picture ID. If you must make a change after the school day has begun, you may fax the note to 540-286-1625.

### **Billing:**

Bi-weekly statements will be sent to all families using the Aviat Care program. Billing is paperless and invoices will be sent to the official school email that is on file in the office. Payment is due within one week of receipt of the statement. A \$10 late fee will be added to any bill that is 60 days past due. A \$25 fee will be added bi-weekly to any bill that is in excess of 90 days.

***Always retain your bi-weekly statements as we do not send out year-end statements since our program is not based on the calendar year.***

### **Medication:**

Holy Cross Academy has a nurse on staff from 10AM to 3PM. If your child needs any medications, please arrange that they are taken while the nurse is on duty. If this will not work, please contact the director.

### **Injuries and Illnesses:**

If your child becomes sick or is injured, we will contact you immediately and will ask that you pick up your child as soon as possible.

### **Unscheduled Early Dismissals:**

In the case of serious inclement weather or any other unscheduled early dismissal from school, we ask that you pick up your child as soon as possible, within an hour of the early dismissal. It may be necessary to have a local emergency contact if you will not be able to come to the school immediately.

### **After-School Activities:**

Students who are participating in athletics or other school activities may remain in Aviat Care until the activity begins. Parents will have to arrange with the coach or activity supervisor to sign their child in and out of Aviat Care. Students may not be unsupervised at any time.
